(Diseased Trees) In 2019, lost several trees to oak wilt. All vulnerable trees were treated per professional recommendations, and have observed no issues since.

(Previous Roof Repairs) In 2017 there was a roof leak in front room (foyer area) due to a flashing issue. Issue was repaired, and then further resolved when metal roof was installed in 2018.

There was also a prior leak in the great room (near the big sliding glass door) due to a flashing issue at that corner. Repaired by Wilson roofing.

(Q4) In 2015 Memorial Day flooding event, water penetrated into the great room due to improper drainage at the front and western side of the property. The issue was resolved through professional grading and installation of French drains around the northwestern corner of the house, with no issues observed since.

For purposes of this notice:
